**Safari Wish:** SCI members turn hunting dreams into realities for hunters with disabilities or who are terminally ill.



Hunters willingly pay a tax on sporting goods in the US that provides billions of dollars of support to wildlife management and conservation. On a global

scale, hunters support the concepts of sustainable use and community-based natural resource management that conserve iconic species such as the lion, elephants, rhinoceros, leopards and cheetahs.

SCI is headquartered in Washington, D.C. in the USA and operates in the USA, Canada, Mexico, Europe and elsewhere around the world. From its headquarters, SCI educates policy-makers, regulators and the public globally on the role of hunting in society and the economy.
