

**Safari Club International (“SCI” or “Sponsor”)
Women Go Hunting Awards Photo Challenge
Sweepstakes Official Rules**

NO PURCHASE, PAYMENT, OR DONATION NECESSARY TO ENTER OR WIN. A PURCHASE, PAYMENT, OR DONATION WILL NOT INCREASE YOUR CHANCES OF WINNING. PARTICIPATION IN THE SCI WORLD HUNTING AWARDS PROGRAM IS NOT REQUIRED TO ENTER OR WIN THIS SWEEPSTAKES.

Eligibility

Open only to women who are legal residents of the fifty (50) United States or Canada (excluding residents of Washington and Quebec) who are at least eighteen (18) years old or the age of majority in their jurisdiction of residence, whichever is older. Employees of Sponsor and their immediate family or household members are not eligible. Void where prohibited by law.

Sweepstakes Period

The Sweepstakes begins June 1, 2026, at 12:00:01 a.m. Pacific Time and ends December 30, 2026, at 11:59 p.m. Pacific Time.

How to Enter

Entrants may enter during the Sweepstakes Period by:

1. Submitting a free online entry form and qualifying photograph at <https://safariclub.org/get-involved/women-go-hunting/hunting-awards-challenge>;
2. Mailing a completed entry form and qualifying photograph to Safari Club International, Attention: Barbara Crown, 654 Richlands Hills Dr., Suite 160, San Antonio, TX 78245; or
3. Entering the SCI World Hunting Awards Program.

Participation in the SCI World Hunting Awards Program is not required to enter or win this Sweepstakes. Each entry submitted through the SCI World Hunting Awards Program includes a \$35 fee associated solely with participation in that separate program and not with participation in this Sweepstakes. Entries submitted through the SCI World Hunting Awards Program and entries submitted through the free methods of entry will receive equal treatment and have equal odds of winning.

Entry Requirements

Photographs must depict an animal legally and ethically harvested by entrant. Entrant must appear in the photograph with the animal. Species must be recognized by the SCI Record Book program.

Photographs must be respectful and may not depict excessive blood, gut piles, unsafe firearm handling, illegal activity, obscene or discriminatory content, alcohol containers, or other inappropriate material as determined by Sponsor in its sole discretion.

Photographs may not be materially altered, deceptively edited, or generated using artificial intelligence or similar technologies in a manner that misrepresents the authenticity of the submission.

By entering, entrant represents that: (a) entrant owns or has permission to submit the photograph; (b) the submission does not infringe any third-party rights; and (c) the animal was taken in compliance with applicable hunting laws and regulations.

Entries that satisfy these objective requirements will be entered into the random drawing. Sponsor will not evaluate, rank, or compare the quality, composition, or content of photographs beyond confirming compliance with these Rules. Any entry that fails to meet the above requirements will be disqualified; all compliant entries will have an equal chance of winning regardless of photographic quality or content.

Number of Entries

Unlimited entries are permitted; however, each submission must include a separate completed entry form and photograph. Automated or mass-generated entries are prohibited.

Prize Drawing

Ten (10) potential winners will be selected in a random drawing conducted on or about January 8, 2027, from among all eligible entries received. Odds of winning depend on the number of eligible entries received. Potential winners will be notified by email at the address provided at entry. Potential winners must respond within seven (7) days of notification to claim their prize or an alternate potential winner may be selected.

Canadian residents selected as potential winners must correctly answer a time-limited mathematical skill-testing question without mechanical or electronic assistance in order to be confirmed as winners.

If a potential winner cannot be contacted, fails to timely respond, fails the skill-testing requirement, or is otherwise determined to be ineligible or noncompliant, Sponsor may select an alternate potential winner.

Prizes

Ten (10) winners will each receive one (1) \$100 Prois Hunting digital gift card. Approximate Retail Value (“ARV”) of each prize: \$100 USD. Total ARV of all prizes: \$1,000 USD. Prizes are non-transferable and may not be redeemed for cash except at Sponsor’s sole discretion. All federal, state, provincial, and local taxes on prizes are the sole responsibility of the winner. Prizes will be delivered electronically to the email address provided at entry within approximately six (6) weeks of winner confirmation. Sponsor is not responsible for prizes that are undeliverable due to an invalid or inactive email address provided by the winner.

License/Publicity Release

By entering, entrant grants Sponsor a perpetual, worldwide, royalty-free license to use, reproduce, publish, display, and distribute submitted photographs and materials in any media for promotional, editorial, educational, archival, and marketing and mission-related purposes without further compensation except where prohibited by law.

Except where prohibited by law, participation in the Sweepstakes constitutes each winner’s consent to Sponsor’s use of the winner’s name, likeness, photograph, biographical information, and submitted materials for promotional purposes without further compensation.

Release and Limitation of Liability

By participating, entrants agree to release and hold harmless Sponsor and its affiliates, officers, directors, employees, agents, and prize providers from any claims arising out of participation in the Sweepstakes or acceptance or use of any prize, except to the extent caused by Sponsor’s gross negligence or willful misconduct where prohibited by law.

Sponsor is not responsible for lost, late, incomplete, damaged, misdirected, or technically corrupted entries or communications.

Privacy

General Conditions

Sponsor may modify, suspend, or terminate the Sweepstakes if fraud, technical failures, force majeure events, or other factors impair the integrity or proper operation of the Sweepstakes. Sponsor’s decisions regarding the Sweepstakes are final and binding.

Disputes/Governing Law

All disputes relating to the Sweepstakes shall be resolved individually, without class action, exclusively in a court located in Bexar County, Texas, and governed by Texas law without regard to conflict-of-law principles.
